As both a manufacturer and importer/exporter of substances<sup>1</sup> covered under REACH, DuPont has established a team to address all of the requirements as they apply to our suppliers, our customers, and our own operations.

DuPont continues to ensure that all products sold to our EU and EEA customers are in compliance with REACH regulatory requirements.

### REACH Registration

REACH requires registration for individual substances (on their own or in mixtures<sup>2</sup>) greater than 1 metric ton per year produced or imported.

The products mentioned above, in our opinion, fulfil the criteria of being classified as “articles”<sup>3</sup>. As supplied, there are no substances intended to be released from these products as defined by article 7 (1) under normal or reasonably foreseeable conditions of use<sup>4</sup>. Under the above conditions, articles are exempt from registration under REACH.

### Substances of Very High Concern (SVHC) on the Candidate List

The above articles to our current knowledge do not contain substances, above the legal threshold, that are on the ‘Candidate List’ of Substances of Very High Concern (SVHC) as published on the ECHA website on **16-07-2019**.

### Authorization


The above articles, to our current knowledge, do not contain any substance listed on Annex XIV, as it was published by European Commission on latest amendment of the Annex XIV of REACH Regulation.

### Restriction

Based on current information, all substances contained in the above articles are in compliance with the conditions of restrictions of REACH Annex XVII. DuPont will communicate in due course, changes due to future amendments of Annex XVII that may impact the manufacture, placing on the market or use of the substances contained in those articles.

<sup>1</sup> Substance: a chemical element and its compounds in the natural state or obtained by any manufacturing process, including any additive necessary to preserve its stability and any impurity deriving from the process used, but excluding any solvent which may be separated without affecting the stability of the substance or changing its composition (REACH, Art. 3.1).

<sup>2</sup> Mixture: means a mixture or solution composed of two or more substances (REACH, Art. 3.2).

<sup>3</sup> Article: means an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition (REACH, Art. 3.3).

<sup>4</sup> As per REACH Art. 7.1 b.
